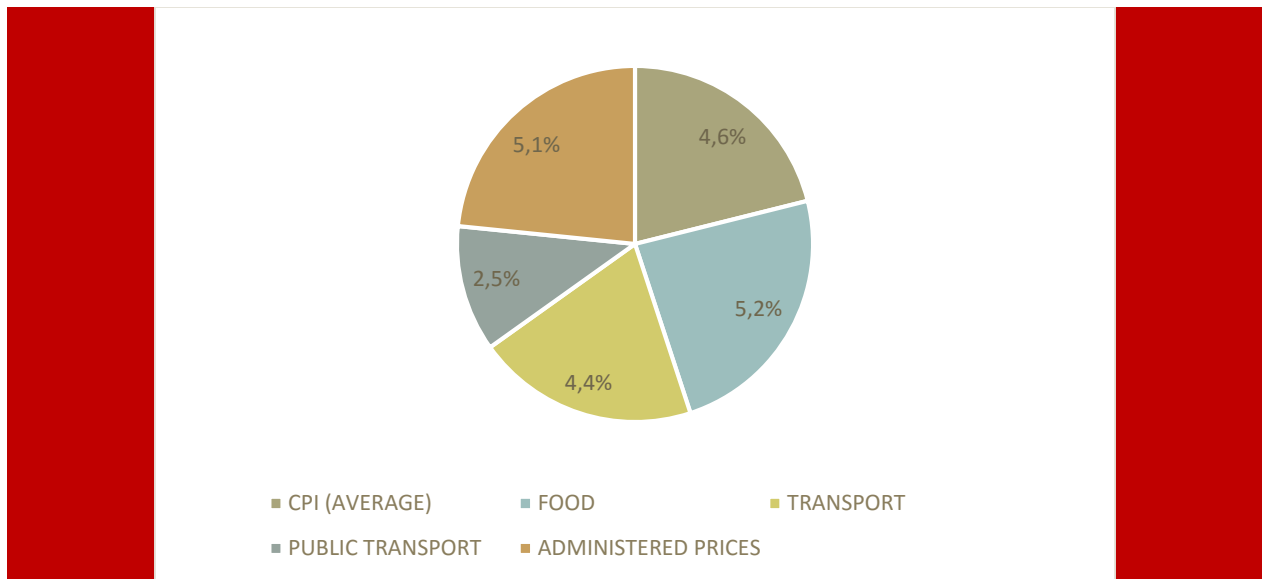

INFLATION MONITOR NOVEMBER 2017



The Consumer Price Index (CPI) eases to 4.6% in NOVEMBER 2017

The term inflation means a sustained increase in the general level of prices for goods and services. It is measured as an annual percentage increase (for example November 2016 to November 2017). Take note that a falling rate of inflation means that prices are rising at a slower rate.

The year-on-year inflation rate as measured by the Consumer Price Index (CPI) slowed down to 4.6% in November 2017 from 4.8% in October 2017.

The Food price declined to 5.2% November 2017 from 5.3% in October 2017

Transport inflation decreased to 4.4% in November 2017 from 5.4% in October 2017.

Public transport inflation decreased to 2.5% in November 2017 from 2.6% in November 2017. (Buses, trains, and other forms of transport that are available to the public, charge set fares, and run on fixed routes.)

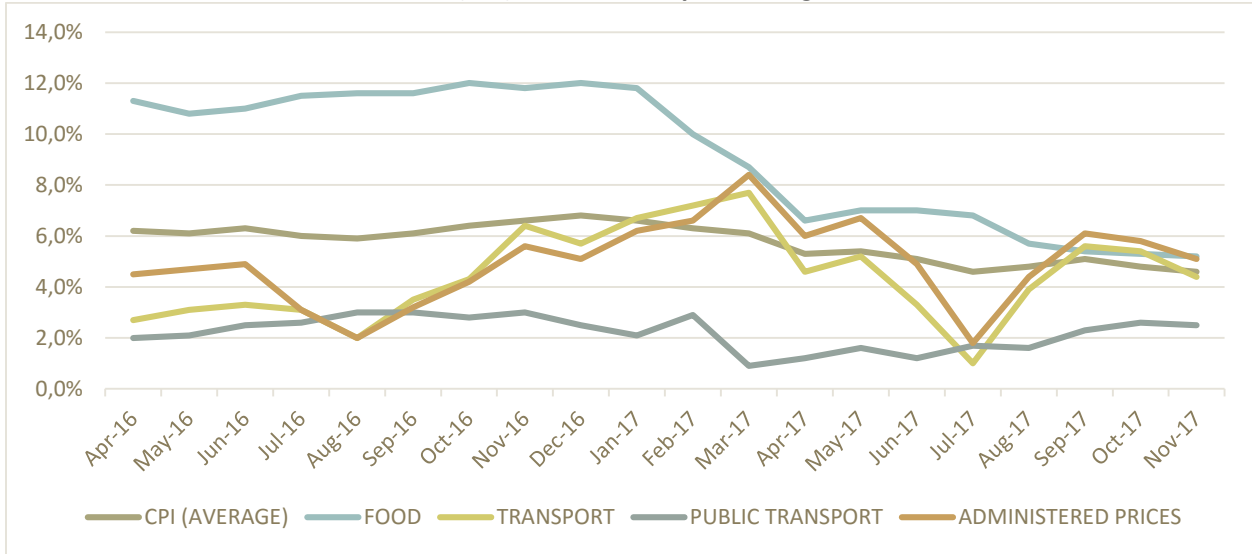
Administrator's price (school fees, telephone fees, electricity, trains, and petrol/paraffin) declined to 5.1% in November 2017 from 5.8% in October 2017.

Consumer Price Index (CPI) Per Expenditure Decile

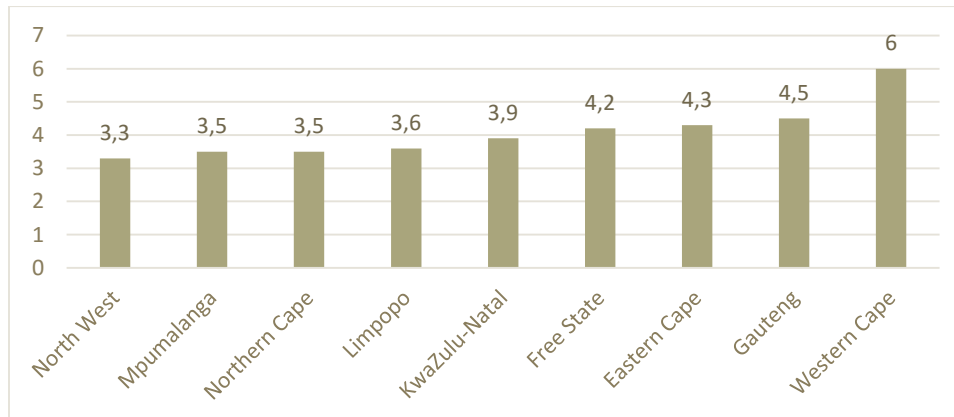
Statistic South Africa divides household monthly expenditure into 10 decile. The table shows that decile 10 expenditure was higher than decile 1 expenditure, indicating a high level of inequality.

The table above shows that there's a different inflation rate for different groups of quintiles. Inflation is lower in the 'very low' decile (1) at 2.0% followed by the 'low' decile (2) at 2.8%, Decile 9 and 10 had the highest inflation rate of 5% and 4.8%. This is higher when compared to the annualise inflation of 4.6%

The province with annual inflation rate **lower than or equal to headline inflation** were North West (3.3%), Mpumalanga (3.5%), Northern Cape(3.5%), Limpopo (3.6%), KwaZulu-Natal (3.9%), Free State(4.2%), Eastern Cape (4.3%) and Gauteng (4.5%).

The provinces with an annual inflation rate **higher than headline inflation** was Western Cape (6%)

The consumer Price Index is known as the headline inflation rate and is also referred to as the official inflation rate. The month to month prices of over a thousand goods and services go into the calculation of CPI.

The food price index shows the increase in the price level of food products only, on a monthly basis. This rate is incorporated in the overall CPI inflation rate (CPI).

The Transport Price Index

The transport price index provides an indication of the increase in then price level of transport items in the basket of goods and services that make up the inflation index. This rate is incorporated in the overall CPI inflation rate.

An administered price is defined as the price of a product, which is set consciously by an individual producer or group of producers and/or any price, which can be determined or influenced by government, either directly or through one or other government agencies/institution without reference to market forces. For example, school fees, telephone fees, electricity, trains, petrol/paraffin, cell calls and public transport. This rate is incorporated into the overall CPI inflation rate.
